- 1. The management of the Company is responsible to ensure the compliances with the requirements of the Companies Act, 2013 and Rules relating to remote e-voting and polling papers on the resolutions contained in the notice of the 29thAGM of the members of the Company. The said Notice was dispatched on the basis of the Register of Members made available by the Registrar& Share Transfer Agent of the Company and the list of beneficial owners made available by the depositories viz. National Securities Depository



Limited (NSDL) and Central Depository Services (India) Limited (CDSL) as on the cut-off date 25th August, 2023.

- 3. As per the provisions of Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, the Company has published Public Notice/advertisement about having sent the notice of the meeting and providing e-voting facility in newspapers having sent the notice of the meeting and providing e-voting facility in newspapers namely 'Financial Express' (English) and 'Ninadam' (Telegu) on 2nd September, 2023.
- 4. The Company appointed CDSL as the platform for remote e-voting before the AGM.
- In terms of the aforesaid notice, voting through electronic means was kept open for three days from 24th September, 2023 at 09:00 A.M. to 26th September, 2023 at 5:00 P.M

The members' details such as their name, folio, number of shares held, who cast their votes through remote e-voting were downloaded from the e voting website of Central Depository Services (India) Limited (CDSL) (https://www.evotingindia.com/) in order to ensure that such members did not vote again through ballot- Poll voting in the 29thAnnual General Meeting. The e-voting results with details of Equity Shareholders who have voted in favour of the resolutions or against the resolutions and those who have obtained from voting were downloaded from the website of Central Depository Services (India) Limited i.e. (https://www.evotingindia.com) under EVSN-230823020

- The voting rights of members were considered in proportion to their shares in the paid up equity share capital of the Company as on the cut-off date i.e. 20th September, 2023.
- After the announcement of Poll by the Chairman, One Ballot box kept for polling was locked in presence of my representative and the members who were present.
- 8. The locked ballot box was subsequently opened in the presence of two witnesses and poll papers were diligently scrutinized.
